**For a week rental or 3-night stay**, : payment for whole stay + 1 deposit cheque for 156 which will be refunded within 2 weeks, unless damage occurred during the stay.

**For monthly rentals (outside summer season), the following will be requested :**

- copies of the last 3 pay slips and/or work contract,
- a cheque equal to the amount of the first rent,
- a deposit cheque, the value of it being equal to a month rent, which will be refunded by bank transfer, within 30 days from leaving, excepted in the case of damage having occurred during the stay,
- a insurance certificate for renting risk cover (fire-explosion-water damage), neighbours claims cover, furniture and theft insurance, personal liability,
- a 30 retainer per month for charges (water and electricity),
- a bank slip.
- each rent must be paid imperatively before the 5th of the month.

THE BOOKING WILL BE EFFECTIVE AS FROM RECEIVING THE DEPOSIT AND THE SIGNED CONTRACT.

**Please note !** Let us know at least one month in advance in the case of cancellation or request for extension of the contract.

Any booking must include a cheque for 25% of the rental amount, as a deposit, which will be deductible from the total amount of the stay.

We accept Holiday Vouchers.

### Important !

Any booking is personal. It is not allowed to sub-let or hand over the use of the cottage to a third person.

**The number of people must not exceed the housing capacity of the cottage.**

Once starting using the cottage, there is no refund possible in the case of having to leave earlier.

Only one single animal will be accepted. The up-to-date vaccination history record must be presented. Owners are responsible for damage caused by their pets.

In the eventuality of an inaccurate statement on the behalf of the tenant, the present contract will be rightfully terminated and amounts paid will be granted to the lessor.

Charges will be calculated at the end of rental (except during summer season).

The cottage will be checked on arrival and again when leaving. (Any damaged item will be charged to the occupant), any deterioration and/or cleaning time (18 per hour as from 1st january 2009) will be taken off the deposit paid on arrival.

**Tenants must necessarily return the cottage in the same state of cleanliness as they found it when arriving.**

**Linen is not supplied : bed sheets, pillow and bolster cases, dishclothes and towels, as well as cleaning products.**
